## Initial Complaint Narrative

02/15/13 THE ORIGINAL LOG # 13-6784 WAS ASSESSED AS AN "OG". THIS IS A SPIN-OFF CCRB\*\*FADO-FORCE ALLEGATION. Sergeant Sedeniussen of the 52nd Precinct called the Command Center to report a prisoner injured in NYPD custody. Defendant [REDACTED] [REDACTED] was double parked at a fire hydrant when he was approached by police. The defendant refused to present his ID card and became combative with officers. The defendant states that six unidentified police officers pulled him from his vehicle and punched him several times in the head. He was taken to [REDACTED] Hospital to be treated for scratches to the back of his neck, pain in his shoulder and ribs and swelling to the right side of his face.
